3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.


4. The programs have been granted accreditation for further 3 years. **Muthayammal Engineering College, Kakaveri, Rasipuram(PO), Namakkal District, Tamil Nadu- 637 408** should submit fresh online application under Tier I SAR document through eNBA portal not before five months from the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Muthayammal Engineering College, Kakaveri, Rasipuram(PO), Namakkal District, Tamil Nadu- 637 408** as a whole. As such the Institution should nowhere along with its name including on its letter head etc. write that it is accredited by NBA because it is program accreditation and not Institution accreditation. If such an instance comes to NBA's notice, this will be viewed seriously.
